PURPOSE

The purpose of this policy is to outline the values of Blackburn English Language School's (ELS) community and explain the vision, mission and objective of the school.

POLICY

Blackburn ELS is committed to providing a safe, supportive and inclusive environment for all students, staff and members of the community. The school recognises the importance of the partnership between school and parents/guardians/carers to support student learning, engagement and wellbeing. We share a commitment to, and a responsibility for, creating an inclusive and safe school environment for all students.

The programs and teaching at Blackburn ELS support and promote the principles and practice of Australian democracy, including a commitment to:

- elected government,
- the rule of law,
- equal rights for all before the law,
- freedom of religion,
- freedom of speech and association, and
- the values of openness and tolerance.

This policy outlines the school's vision, mission and objective and expectations of its school community. This policy is available on the school website, staff Induction Handbook and in the enrolment pack.

To celebrate and embed our Statement of Values and Philosophy in the school community, we

- display posters and banners that promote the school's values,
- celebrate the school's values in the newsletter,
- provide awards and recognition for students who actively demonstrate the school's values,
- discuss the school's values with students in the classroom, meetings and assemblies.

Blackburn English Language School is an inclusive, engaging and rigorous learning environment that enables newly arrived students to improve their English language proficiency and empowers them with the knowledge and skills to be confident, active participants in the Victorian schooling system and broader community.

Blackburn ELS' objective is to ensure all students leave our school with confidence and competence in their English language knowledge and skill.

BEHAVIOURAL EXPECTATIONS

Blackburn ELS acknowledges that the behaviour of staff, parents/guardians/carers and students has an impact on the school community and culture.

The school acknowledges a shared responsibility to create a positive learning environment for all its students.

As principals and school leaders, we will:

- model positive behaviour and effective leadership
- communicate politely and respectfully with all members of the school community
- work collaboratively to create a school environment where respectful and safe behaviour is expected of everyone
- ensure all parents/carers are aware of the expectations outlined in the Department's Respectful Behaviours within the School Community Policy
- behave in a manner consistent with the standards of our profession and meet core responsibilities to provide safe and inclusive environments
- plan, implement and review our work to ensure the care, safety, security and general wellbeing of all students at the school
- identify and support students who are or may be at risk
- do our best to ensure every student achieves their personal and learning potential
- work with parents to understand their son/daughter's needs and, where necessary, adapt the learning environment accordingly
- respond appropriately when safe and inclusive behaviour is not demonstrated and implement appropriate interventions and sanctions when required
- inform parents of the school's communication and complaints procedures
- ask any person who is acting in an offensive, intimidating or otherwise inappropriate way to leave the school grounds.

As teachers and non-teaching school staff, we will:

- model positive behaviour to students consistent with the standards of our profession,
- communicate politely and respectfully with all members of the school community,
- proactively engage with parents/guardians/carers about student outcomes,
- work with parents/guardians/carers to understand the needs of each student and, where necessary, adapt the learning environment accordingly,
- work collaboratively with the SWC and sector and curriculum leaders to improve learning and wellbeing outcomes for students with additional needs,
- communicate with the principal and school leaders in the event we anticipate or face any tension or challenging behaviours from parents/guardians/carers,
- treat all members of the school community with respect.

As parents/guardians/carers, we will:

- model positive behaviour to our son/daughter,
- communicate politely and respectfully with all members of the school community, in line with the Department's [Respectful Behaviours within the School Community Policy](#)
- ensure our son/daughter attends school on time, every day the school is open for instruction,
- take an interest in our son/daughter's school and learning,
- work with the school to achieve the best outcomes for our son/daughter,
- communicate constructively with the school and use expected processes and protocols when raising concerns,
- support school staff to maintain a safe learning environment for all students,
- follow the school's processes for communication with staff and making complaints,
- treat all school leaders, staff, students, and other members of the school community with respect.

As students, we will:

- model positive behaviour to other students,
- communicate politely and respectfully with all members of the school community,
- comply with and model school values,
- behave in a safe and responsible manner,
- respect ourselves, other members of the school community and the school environment.
- actively participate in school,
- not disrupt the learning of others and make the most of our educational opportunities.

As community members, we will:

- model positive behaviour to the school community,
- treat other members of the school community with respect,
- support school staff to maintain a safe and inclusive learning environment for all students,
- utilise the school's processes for communication with staff and submitting complaints.

UNREASONABLE BEHAVIOURS

Schools are not public places. The principal has the right to permit or deny entry to school grounds.

Unreasonable behaviour that is demonstrated by school staff, parents/guardians/carers, students or members of the school community will not be tolerated at school, or during school activities.

Unreasonable behaviour includes:

- speaking or behaving in a rude, manipulative, aggressive or threatening way, either in person, via electronic communication or social media, or over the telephone;
- sending demanding, rude, confronting or threatening letters, emails or text messages;
- discriminatory or derogatory comments;
- the use of social media or public forums to make inappropriate or threatening remarks about the school, staff or students.

Harassment, bullying, violence, aggression, threatening behaviour and unlawful discrimination are unacceptable and will not be tolerated at the school.

Unreasonable behaviour and/or failure to uphold the principles of this *Statement of Values and School Philosophy* may lead to further investigation and the implementation of appropriate consequences by the school principal.

At the principal's discretion, unreasonable behaviour may be managed by:

- requesting that the parties attend a mediation or counselling sessions
- implementing specific communication protocols
- written warnings
- conditions of entry to school grounds or school activities
- exclusion from school grounds or attendance at school activities
- reports to Victoria Police
- legal action.

Inappropriate student behaviour will be managed in accordance with our school's *Student Wellbeing and Engagement Policy* and *Bullying Prevention Policy*.

Our *Statement of Values and School Philosophy* ensures that everyone in our school community is treated with fairness and respect. In turn, the school strives to create an environment that is inclusive and safe, where all members are empowered to participate and learn.


